Har VaGai Regional High School is a six year school with an intake of pupils from 54 different settlements in the Upper Galilee & The Golan Heights. The school acts in order to strengthen the pupil's involvement in their surroundings, and advances the connection of both its pupils & teaches to the Jewish People and the State of Israel.

2. **Need/Program Purpose:** Describe the purpose of the program /the need it comes to address.

The school's vision in the field of the computerization program comes to prepare the pupils of today for the world of tomorrow, and to provide them with advanced technological tools, an innovative learning environment, and advanced teaching methods. In order to complete the process, the school needs another 20 (twenty) laptop computers.
